- Online Banking Access will be provided to signatory's for all accounts listed when requested. If jointly-operated accounts held a transaction will be set up via Business Banking allowing one member to set up the transaction and then approved by another before it is processed ensuring that 'joint to sign' authority is being followed.
- If you are an existing Member of Defence Bank, your Member Number, details provided along with valid identification will be used to verify you through AML/CTF legislation. Where no active membership is held, these details will be used to create a Signatory Membership profile to attach your signing authority to the nominated accounts requested.
- The completion of the Tax Residency Declaration is mandatory for all individuals connected to this membership as Defence Bank is required to comply with reporting obligations under the Foreign Account Tax Compliance Act 2010 (FATCA) and Common Reporting Standards (CRS) legislation. If the individual is not an Australian resident for taxation purposes, they must also complete a Foreign Tax Declaration Form.
